To All Youth Court Jurors:

The following guidelines have been provided to the jury to aid in creating an appropriate sentence. It is expected that the sentence imposed by the jury will be within the guidelines. If the jury has good cause to do so, however, the jury may impose a sentence outside these guidelines.

See Category 1 below for these cases: Curfew, Trespass, Tobacco, Skateboarding, and Prowling (and variations)

See Category 2 below for these cases: Disorderly Conduct, Receiving Stolen Property, Theft, Harassment, Graffiti, Possession of Drugs, Possession of Alcohol (and variations)

See Category 3 below for these cases: Assault, Battery, Possession of Weapons, all other Vandalism, Resisting an Officer, Filing False Police Reports (and variations)
